**3. Annual Financial Overview of the Water and Sewer Utility For the Year 2019**

Total Water and Sewer Revenue ( R )	\$	271,265
Total Water and Sewer Expenditures ( E )	\$	223,994
Total debt payments on water and sewer infrastructure loans ( D )	\$	94,485

For the year 2019 water and sewer revenue covered eighty five percent of the water and sewer expenditures.

*Please note that Council has resolved to NOT fully fund amortization of water and sewer infrastructure for the year 2019. Inclusion of annual amortization in the Total Expenditure amount increases total expenditures by \$73,725. If amortization is removed, Total Water and Sewer Expenditures are*

*Taking into account Council's decision to not fund amortization in 2019, the utility is covering 110.83% of the cash water & sewer expenditures for the year 2019.*
